I understand that I must remove contact lenses prior to any lash treatment (lash tint, lash lift and SPM) being performed. Contact lenses can be re-inserted 24 hours after the treatment if no irritation or side effects have occurred.

I understand there are risks inherent in the procedure and there is a possibility of complications during and after the procedure.

I hereby acknowledge that all information I have provided to my therapist is true and correct, and I am fully aware of the risks of the procedure/s I am undertaking. I therefore take full responsibility for all possible outcomes of the procedure.

**AFTERCARE INFORMATION:**

**WAXING:**

- Dependent on your skin sensitivity, you may be vulnerable to skin lifting or reactions to the wax, or the other products used on your skin during the procedure.
- Avoid touching the area for 24 hours.
- Avoid using moisturizers, creams, lotions, deodorant, fake tan and makeup on waxed areas for 24 hours.
- Avoid hot showers, swimming pools, saunas, tight clothing, and direct sunlight for 24 hours.
- Do not exfoliate the area for 2-3 days, then exfoliate 2-3 times per week.

**SPRAY TANNING:**

- Avoid contact with water and sweat until it is time to rinse off your tan.
- Avoid waxing and exfoliating (you will remove your tan).
- Avoid friction/rubbing on the skin before it's time to rinse off your tan.
- Moisturize your skin every day after showering, or use a gradual tanning lotion beginning on day 3, to help your tan last longer.

**TINTING & HENNA:**

- Never open your eyes during a tinting procedure. This may cause temporary or permanent irritation or damage to your eyes.
- Dependent on your skin type, there is no guarantee that the tint/henna will stain your skin, or how long the tint/henna will remain on your skin/hair.
- Dependent on your skin type, Henna can have a drying effect on your skin.
- Henna will not last as long on oily skin, but will improve with continued use of Henna.
- Henna and tint will not adhere as well, if at all, to scar tissue.
- Wearing mascara (after a lash tint) may reduce the longevity of the tint.
- Do not use oil based makeup remover as this will reduce the longevity of your tint/Henna and may even remove the tint/Henna all together.
- Do not use fake tan for at least 24 hours, as this will turn your tint green.
- Do not get the tint/henna wet for 24 hours.
- If you wear sunscreen, use a physical barrier type like zinc cream or titanium dioxide, as chemical sunscreens accelerate Henna fading.
- Chlorine and salt water will fade the Henna faster than usual.

**LASH LIFTING:**

- Never open your eyes during a lash lifting procedure. This may cause temporary or permanent irritation or damage to your eyes.
- Avoid getting the lashes wet for 24 hours.
- Lashes may not achieve the amount of lift you were expecting, in which case, inform your therapist so the procedure can be modified next time.
- Avoid wearing eye make up for 24 hours.
- Do not rub your lashes.
- Do not use an eyelash curler.
- Do not wear contact lenses for 24 hours after treatment.
- Avoid swimming, sauna, steamy showers and sweating for 24 hours.
- Everyone's eyelash hair is different; some lashes may hold the curl longer, or less, than others.
- Do not sleep on your lashes.

**SEMI-PERMANENT MASCARA (SPM):**

- Never open your eyes during the SPM treatment. This may cause temporary or permanent irritation or damage to your eyes.
- Do not rub your lashes.
- Do not wear mascara.
- Do not use oil based products on lashes.
- Avoid getting lashes wet for 8 hours.
- Avoid swimming, steamy showers, sweating and sauna for 8 hours.
- Do not wear contact lenses for 8 hours after the treatment.
- Do not wear any eye makeup for 8 hours.
- Do not sleep on your lashes.
